SCHOOL FEE PAYMENT AND PROCEDURE: 2025

At the General Finance Meeting held at the school on Monday, 04th November 2024, following fee structure approved by all the parents present:

Grade 8 – Grade 12: R32500.00 per annum

Please note the following important points with regard to the payment of fees:

1. We refer you to Section 41 of the South African Schools Act 84 of 1996 where it stated that by law parents who are liable, are required to pay school fees set by the Governing Body and approved by the parent body.
2. The school has already budgeted for certain costs for the academic year. You are reminded that the full fee is payable in advance (at the start of the school year).
However, the following options have been approved as methods of payment:

- **Lump sum:** A once-off payment with a fee discount on a sliding scale as follows:

Full payment received by 31 st January 2025	-	10 %	- R29250.00
Full payment received by 28 th February 2025	-	10 %	- R29250.00
Full payment received by 31 st March 2025	-	7 %	- R30225.00
Full payment received by 30 April 2025	-	5 %	- R30875.00

- **Monthly:** 10 payments of R3250.00 made from January to October 2025. (Direct banking or Internet transfers)
- **Debit Order:** Should you choose to pay by debit order this facility will consist of
10 payments of R3250.00 (February to November 2025)-

All cash payments made directly into the school's bank account

3. The school must be aware of your preferred payment option at the beginning of the school year. A return advice slip sent out at the beginning of the year for you to indicate your option choice. A monthly Debit Order application form sent out should you choose this method of payment.
4. Should your account fall into arrears, the process of handing the account over to attorneys for you will initiate collection with all collection costs due. In order to avoid unnecessary costs we urge you to either pay your fees timeously, or make an appointment with the Bursar of the school if you are unable to meet any payment deadline.
5. The payment of school fees is the primary obligation of parents. All monies paid to the school directed to the school fee account first.
6. All applications for full or partial school fee exemption must be made to the school governing body on or before 28 February 2025. A completed application form (which may be collected from the school bursar) must be accompanied by all of the relevant documents which are listed on page 1 and 2 of the application form.

N.B It is **not** in the interest of *sustainability* and *quality* outcomes to make use of the exemption, unless the parent is in a difficult situation. Discuss your financial situation with us.
